15	Sudden use of the brakes without justification
15	Failure to leave sufficient distance with the vehicle in front of it
15	Failure of transport vehicles to adhere to the right side of the road
15	Failure to take precautions for traffic coming behind and in front of it when turning
15	Failure to use the turn signal
15	Failure to adhere to the right side when wanting to turn right
15	Failure to give way to another vehicle to overtake
15	Violation of police instructions regarding traffic regulation
15	Failure to adhere to the right side of the road and poor visibility
15	Speeding less than the maximum and not adhering to the right side of the road
15	Escaping from the patrol
15	Using the vehicle for advertising without a permit
15	Failure to make way for official convoys
15	Failure to make way for approved emergency vehicles
15	Failure to place the insurance sticker
15	Violation of truck traffic times
15	Failure to attach a photo of the vehicle number behind the front seat (On-demand fare)
